I. NAME

The name of the corporation, hereinafter called the "Association," is SEASONS COURT ASSOCIATION.

II. PURPOSE

- This corporation is a nonprofit mutual benefit corporation, organized under the Nonprofit Mutual Benefit Corporation Law. purpose of this corporation is to engage in any lawful activity for which a corporation may be organized under such law.

Further, the purpose of this corporation is to act and be operated as a homeowners association as defined in Section 528 of the Internal Revenue Code of 1354 and Section 23701t of the California Revenue and Taxation Code, as amended, and to provide for the maintenance, preservation, and architectural control of the residence Lots and Common Area within that certain tract of property described as:

Lots 1 through 35, inclusive, being all of the property of Seasons Court Subdivision as more particularly described on the Map thereof recorded on the 28 day of July in Book 26 at Page 180 of Maps, records of Madera County California.

- A. The management of the activities and the conduct of the affairs of the corporation shall be:
- (1) To promote the health, safety, and welfare of the residents within the above-described property and any additions thereto as may hereafter be brought within the jurisdiction of this Association for this purpose;
- (2) To perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions, hereinafter called the "Declaration," applicable to the property and recorded or to be recorded in the office of the Recorder of the County of Madera, State of California;
- (3) To fix, levy, collect, and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed against the property of the Association;
- (4) To acquire (by gift, purchase, or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the Association;
- (5) With the assent of two-thirds of the Class A members, excluding the declarant subdivider, borrow money, mortgage, pledge,

execute deeds of trust, or hypothecate any or all of its real or personal property as security for money borrowed for debts incurred.

- of the Common Area to any public agency, authority, or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless and instrument has been signed by two-thirds of Class A members, other than the declarant subdivider, agreeing to such dedication, sale or transfer.
- (7) To participate in mergers and consolidations with other nonprofit corporations organized for the same purposes or annex additional residential property and Common Area, provided that any merger, consolidation, or such annexation shall have the assent by vote of two-thirds of Class A members, excluding the declarant subdivider, or by written consent of two-thirds of Class A members, excluding declarant subdivider

V. MEMBERSHIP

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot which is subject by covenants of record to assessment by the Association, including contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separate from ownership of any Lot which is subject to assessment by the Association.

VI. VOTING RIGHTS

The Association shall have two classes of voting memberships:

Class A

Class A members shall be all Owners with the exception of the Declarant and shall be entitled to one vote for each Lot owned.

When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any Lot.

Class B

Class B members shall be the Declarant (as defined in the Declaration), and shall be entitled to three (3) votes for each Lot owned. The Class B membership shall cease and be converted to Class A membership on the happening of any of the following events, whichever occurs earliest:

- (a) When the total votes outstanding in the Class A membership equal the total votes outstanding in the Class B membership; or
- (b) On June 1st , 1983 , which is the second anniversary of the original issuance of the subdivision public report for the development.

VII. BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of nine (9) Directors, who need not be members of the Association. The number of directors may be changed by amendment of the Articles of the Association. The names and addresses of the persons who are to act in the capacity of directors until the selection of

At the first annual meeting, the members of the Association shall elect three (3) directors for a term of one (1) year, three (3) directors for a term of two (2) years, and three (3) directors for a term of three (3) years; and at each annual meeting thereafter, the members shall elect three (3) directors for a term of three (3) years.

VIII. LIMITATION OF POWERS

Without the approval of 100% of the members, any contrary provisions in these Articles or the By-laws of the Association not-withstanding, so long as there is any lot, parcel, area or unit for which the corporation is obligated to provide management, maintenance, preservation or control, (a) the owners of the Association or any person acting on its behalf shall not:

- 1. Transfer all or substantially all of its assets; or
- 2. File a certificate of dissolution.

IX. DURATION.

The corporation shall exist perpetually.

X. FHA/VA APPROVAL

As long as there is a Class B membership, the following actions will require the prior approval of the Federal Housing Administration or of the Veterans Administration: annexation of additional properties, mergers and consolidations, mortgaging of Common Area, dedication of Common Area, dissolution of the Association, and amendment of these Articles.

XI. AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended by the vote or written assent of two-thirds of the Class A members, excluding the subdivider declarant.


